- Children who read regularly and widely, achieve better in school
- Reading every night 10 minutes
- Ask questions about the book build skills
- Note in their diary how many pages read
- Signed
- Story time
- Guided reading



Reading

- Reading books will be changed 3 times per week in Year 1.
- Mondays/Wednesdays/Fridays please make sure that your child brings in their book bag on these days.
- Guided reading sessions 3 times per week, first lesson to decode, second to focus on prosody and third lesson focusing on comprehension.
- We will be sending phonics books home on a Friday this year.
- Monday and Wednesday will be a book to read for pleasure.

Phonics

- Everyday we have Phonics lessons to recap and secure sounds and tricky words – this goes hand in hand with Handwriting lessons and reading.
- At the end of Year 1 the children will be assessed on their Phonics through a Phonics Screening Check (in June).



Times Tables

- Introducing Times Tables starting with 10s
- Knowing your tables makes lots of areas of maths so much easier
- By the end of Y1 all the children should know 2's, 5's and 10's
- Times tables practice will continue all year during Maths and through Mastering number sessions every day



Homework

 Will be sent out to enhance and consolidate children's learning

Food and Drink

- Packed lunches healthy packed lunches

- Milk letter (there is a charge unless your child is registered for free school meals)

Pupil Premium Funding

- School receives £1445 for every child entitled to free school meals
- This funding provides additional staff, trips and resources to support these children in school
- Even if your child is on packed lunches or is in Y1 & Y2 and you think your child may be eligible, please let the office know and they will support you in applying

Free School Meals

All children in Y1 can have a free school meal. However if they are entitled for free school meals please can you apply as school receives the extra funding. You can apply for free school meals if you or your child receive any of the following:

- Income Support
- Income-based Jobseeker's Allowance
- Income-related Employment and Support Allowance
- Support under Part VI of the Immigration and Asylum Act 1999
- The Guarantee element of State Pension Credit
- Child Tax Credit, provided they are not entitled to Working Tax Credit and have an annual income of £16,190 or less
- Working Tax Credit 'run-on' the payment someone may receive for a further four weeks after they stop qualifying for Working Tax Credit
- Universal Credit In England, if you apply on or after 1 April 2018 your household income must be less than £7400 a year (after tax and not including any benefits you get)
